New bill to simplify charity law put before parliament

The Charities Bill, which will consolidate existing charity legislation, is going through Parliament.

The Bill will bring together three separate Acts which relate to charity law – the Recreational Charities Act 1958, the Charities Act 1993 and the Charities Act 2006.

The Charities Bill has been prepared by the Law Commission working with the Office for Civil Society and the Charity Commission.

Nick Hurd, minister for civil society, said:

“Charity legislation is extremely difficult to navigate, particularly for the untrained reader. The Charities Bill is to be welcomed. The Bill will make it easier for people to understand and follow charity law.

“I am grateful to the Law Commission for preparing this consolidation.”
The Bill had its first reading last week in the House of Lords.

Government names new partner to deliver Community Organisers

The government has announced the selected partner who will deliver and train up to 5,000 Community Organisers.



Locality - a new nationwide network of community led organisations, formed through the merger of the Development Trusts Association (DTA) and bassac - has been chosen to carry out a range of work including developing a training framework, Code of Conduct for Community Organisers, and an Institute for Community Organising.

Community Organisers will be well-trained and committed individuals who will play a major role in delivering the Big Society. They will work closely with communities to identify local leaders, projects and opportunities, and empower the local community to improve their local area.

Nick Hurd, Minister for Civil Society, said:

I am pleased to announce Locality as our partner in delivering Community Organisers. The Organisers, who will be driven by local communities needs, will encourage social action and enable individuals to shape the services that matter most to them. The Big Society is about empowering people and the Community Organisers will play a key role by giving people a chance to improve the community in which they live.

Who should be eligible for adult care?

Consultation has begun into proposals to change the eligibility criteria for people who want care support and Lincolnshire County council would like to hear the views of as many people as possible.

Called Fair Access to Care, the county council provides services to people assessed as having moderate, substantial and critical levels of need. People with low levels of need are not eligible for council-funded support

Under new proposals out for consultation, people with moderate needs would not be eligible for funding but would be supported through prevention and re-ablement services.

The Cruse Bereavement Care Foundation Course 'Awareness in Bereavement Care' comprises 16 x 3 hours sessions covering all aspects of supporting bereaved individuals. The course will be held over the following dates:

- Monday 4th April & Monday 11th April (6.30pm – 9.30pm)
